JOB VACANCY DELINQUENCY CONTROL OFFICER – HEAD OFFICE

Applications are invited from interested and suitably qualified individuals to fill the position of **Delinquency Control Officer (DCO)** at our Toledo Teacher's Credit Union Head Office in Punta Gorda Town, Toledo District.

Terms of Reference:

The DCO will be responsible for the recovery of delinquent loans by following Loan Recovery Procedures set out by the Credit Policies and Procedures Manual.

Key Responsibilities:

- Ensure delinquency rate does not exceed 5% of loan portfolio
- Work closely with Credit Officers at both offices on measures to control delinquency
- Prepare Court documents and attend court sessions as set out by Collection Agent and Attorney
- Prepare Monthly and Quarterly Delinquency Reports

Education and other requirements:

- Associate's degree in business administration or related field and three (3) years working experience
- Paralegal Certificate would be an asset
- Must be organized, proactive, analytical, flexible and possess a strong ability in writing
- Good working knowledge of Microsoft Office Suite and Automated Accounting Systems
- Fluent in English & Spanish. Able to speak fluent Kekchi and/or Mopan would be an asset
- Must be in possession of a Valid Class A Driver's License
- Ability to work a few days per month at the Branch Office in Bella Vista Village
