## **JOB VACANCY**

Applications are invited from interested and suitably qualified individuals to fill the position of <u>Assistant</u> <u>Compliance Officer</u> at our Toledo Teacher's Credit Union Head Office in Punta Gorda Town, Toledo District.

## **Key Responsibilities:**

- Act as the Alternate Compliance Officer when necessary
- Develop/update compliance policies and procedures.
- Report directly to the FIU AS PER REQUIREMENTS & as may deem necessary.
- Develop a program to communicate policies and procedures to employees, management, and directors.
- Monitor staff compliance with the policies and procedures contained in the CU's Anti Money Laundering (AML) Manual
- Receive internal reports and consider them to determine whether they give rise to knowledge or suspicion of money laundering or terrorist financing.
- Monitor the accounts of members (updating, economic profile, risking, etc.).
- Act as liaison where the CU is required to act in accordance with the instructions of the law enforcement authorities.
- Liaison to discuss with the CBB or the FIU matters pertaining to the AML/CFT functions.
- Develop Training Content for Staff

## **Education and other requirements:**

- Associates Degree in Business Science/Management
- Anti-Money Laundering Certified Associate (certificate course) an asset.
- Possession of a class A driver's license is an asset.
- Requires general knowledge of financial institution's operations, regulations, and services.
- Possess one to three years of specific or related experience with the ability to demonstrate honesty, integrity, credibility, confidentiality, and responsibility.
